Central European University | is a graduate-level “crossroads” university where faculty and students from some 100 countries come to engage in interdisciplinary education, pursue advanced scholarship, and address some of society’s most vexing problems.

Founded in 1991 in response to the revolutionary changes that were transforming Central and Eastern Europe, CEU is based on the premise that human fallibility can be counterbalanced by the critical discussion of ideas and that this critical spirit can be sustained best in societies where people are free to choose the nature and direction of their government.

Located in Budapest and accredited in the United States and Hungary, CEU draws on the research tradition of great American universities and on the most valuable intellectual traditions of Central Europe. It offers English-language programs in the social sciences, humanities, business, law, environmental sciences, mathematics, and public policy.

With some 1,400 students and 400 faculty members from over 100 countries, CEU is one of the most densely international universities in the world. Its rare mix of nationalities, ethnicities, and cultures creates an ideal environment for sharing perspectives and challenging assumptions. Students, faculty, researchers, and visitors come together to explore such intriguing topics as emerging democracies, transitional economies, media freedom, constitution building, nationalism, human rights law, and conflict resolution.



OPEN SOCIETY

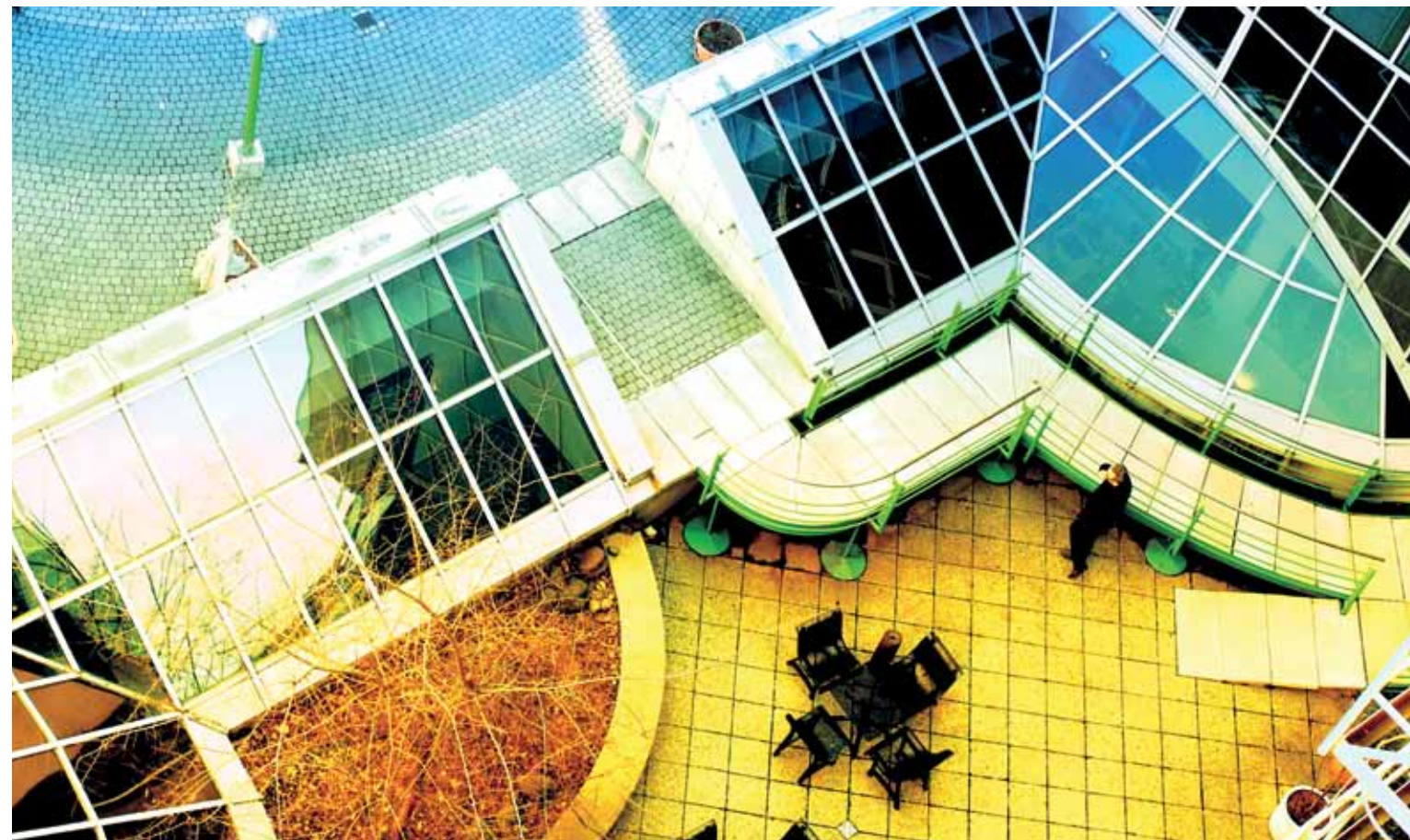
In 1989, a group of visionary intellectuals from Central and Eastern Europe—including prominent members of the anti-totalitarian democratic opposition—conceptualized an international university that would help facilitate the transition from dictatorship to democracy in the region. Among them was George Soros, the

Hungarian-American financier and philanthropist, who founded CEU two years later in 1991.

Soros championed the project because he believed that open societies flourish best when people in positions of responsibility are prepared to advance democratic principles. His vision was to recruit professors and students to build a unique institution, one that would

train future generations of scholars, professionals, politicians, and civil society leaders to contribute to building open societies that respect human rights and adhere to the rule of law.

CEU opened in three cities simultaneously: Budapest, Prague, and Warsaw. A single consolidated campus was established later in Budapest.



DISTINCT APPROACH

CEU's distinctive academic approach combines regional studies with an international perspective.

A master's student might, for example, take a course such as the sociology of ethnic prejudice, accountability for war crimes, or media freedom in a pluralist world, examining theories and cases from various parts of the world. Recent doctoral dissertations explored "legal regulation of non-mainstream religious groups" and "self-reflection in post-criminal societies: from denial to moral responsibility." The Center for Policy Studies is conducting a cross-national study to shed light on public knowledge and attitudes on human trafficking. And CEU Business School offers professionals on three continents the chance to earn an MBA via a seven-school international executive education partnership.

Between 1991 and 2013, CEU has graduated 11,000 students, who are living and working in 120 countries on five continents.

As CEU proceeds into its third decade, open society values and practices are being tested worldwide. Reemerging nationalism erodes international cooperation. Racism and xenophobia foment discrimination and violence. New surveillance technologies erode privacy. And climate change threatens environmental and economic stability. At the same time, struggles for self-governance in countries as disparate as Egypt, Burma, and South Sudan demonstrate the difficulties of change. Through its faculty, students, and alumni, CEU is engaged with such challenges every day, worldwide.

"My interest in energy policy began when I interned for the U.S. State Department in Prague. The EU's goal of generating 20 percent of energy with renewable sources by 2020 had recently been adopted by the Czech Republic and, with policies to promote investment in the solar industry, interest was high. Though these policies turned the country into one of the world's largest solar producers, they also led to market distortions and higher electricity prices. Retroactive legislation to rectify the problems—and subsequent lawsuits—offers a cautionary tale about intervention in the energy sector."

"In Nairobi, where I grew up, 60 percent of the population lives in slums on less than 5 percent of the residential land. We had youth groups trying to change things and, for me, questions of justice arose very clearly. Before coming to CEU, I was a program coordinator at Kituo Cha Sheria (Centre for Legal Empowerment). We lobbied heavily for changes to the Kenyan constitution to include community land rights that aligned better with socioeconomic rights and justice. In 2010, 67 percent of Kenyans voted to approve the new constitution with these provisions."

ACADEMICS

Central European University has 14 departments and two schools in the social sciences, humanities, business, law, environmental sciences, mathematics, and public policy. Its newest addition is the School of Public Policy, which enrolled its inaugural class for the 2013-14 academic year.

CEU has achieved global recognition for a variety of its academic programs—including political science, international relations, public policy, philosophy, and sociology—while investing in exciting new fields such as cognitive science and network science. Within the region, many of its programs enjoy premier status, including business and law.

In both traditional and emerging fields, CEU emphasizes the importance of crossing disciplinary lines to address complicated issues. It pursues creative ways of integrating theoretical research with professional practice. And it convenes leading thinkers from around the world to explore the roots of modern societal challenges. Among CEU's degree programs are three two-year



INTERDISCIPLINARITY

Complex societal challenges require problem-solvers with diverse but complementary knowledge and skills. At CEU, students learn to think multi-dimensionally about such subjects as bioethics and corporate responsibility, climate change and media freedom, data privacy and terrorism.

"Transnational Environmental Politics" is a course offered by the departments of International Relations and European Studies and Environmental Sciences and Policy that explores conflicts over resources essential for security, specifically energy, food, and water. Another course, "Empires," taught by the departments of Gender Studies and Medieval Studies, examines unequal relationships of power and social position, highlighting the legal, political, and sociocultural consequences of empire-building.

Erasmus Mundus master's programs delivered in concert with other leading European institutions: in public policy, environmental sciences and policy management, and gender studies. Funded by the European Union, these highly competitive and prestigious programs award scholarships to top students worldwide to foster intellectual cooperation and research in Europe.

CEU draws on the wealth of knowledge and perspectives its multicultural student community provides. With an outstanding 8:1 student/faculty ratio, CEU enables faculty members to help develop students' critical thinking skills and to explore their individual research interests.

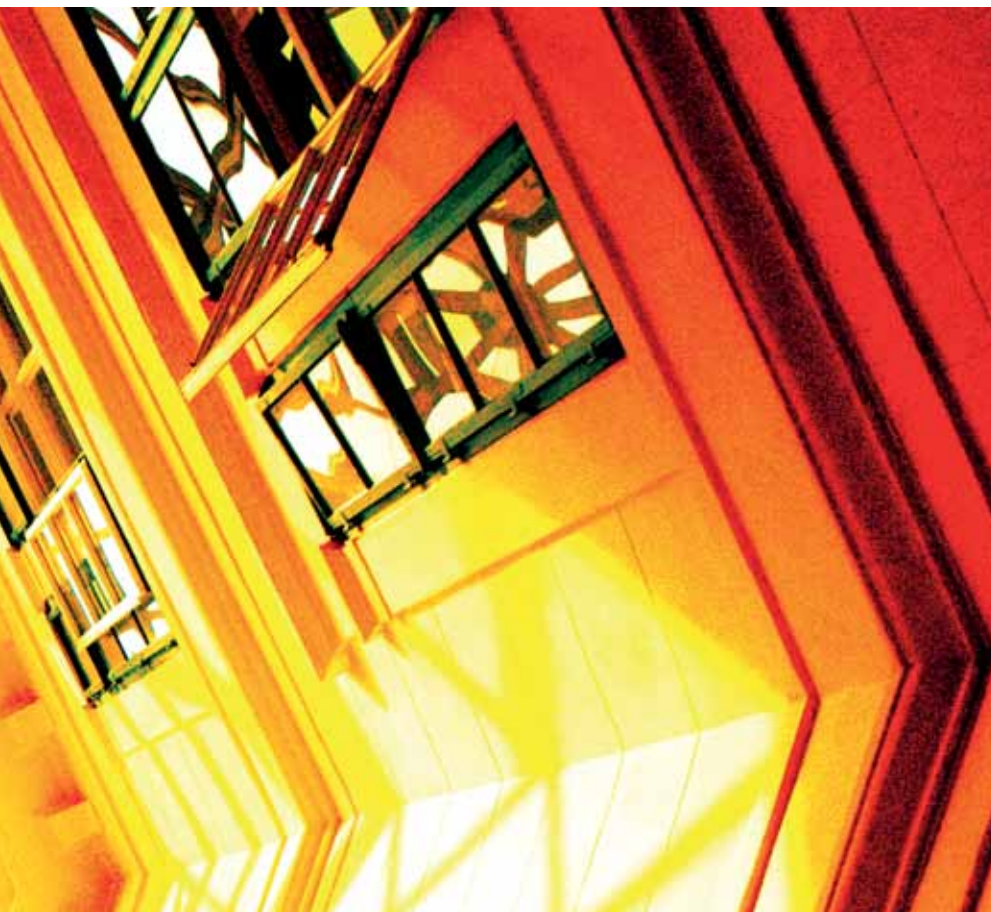

RESEARCH

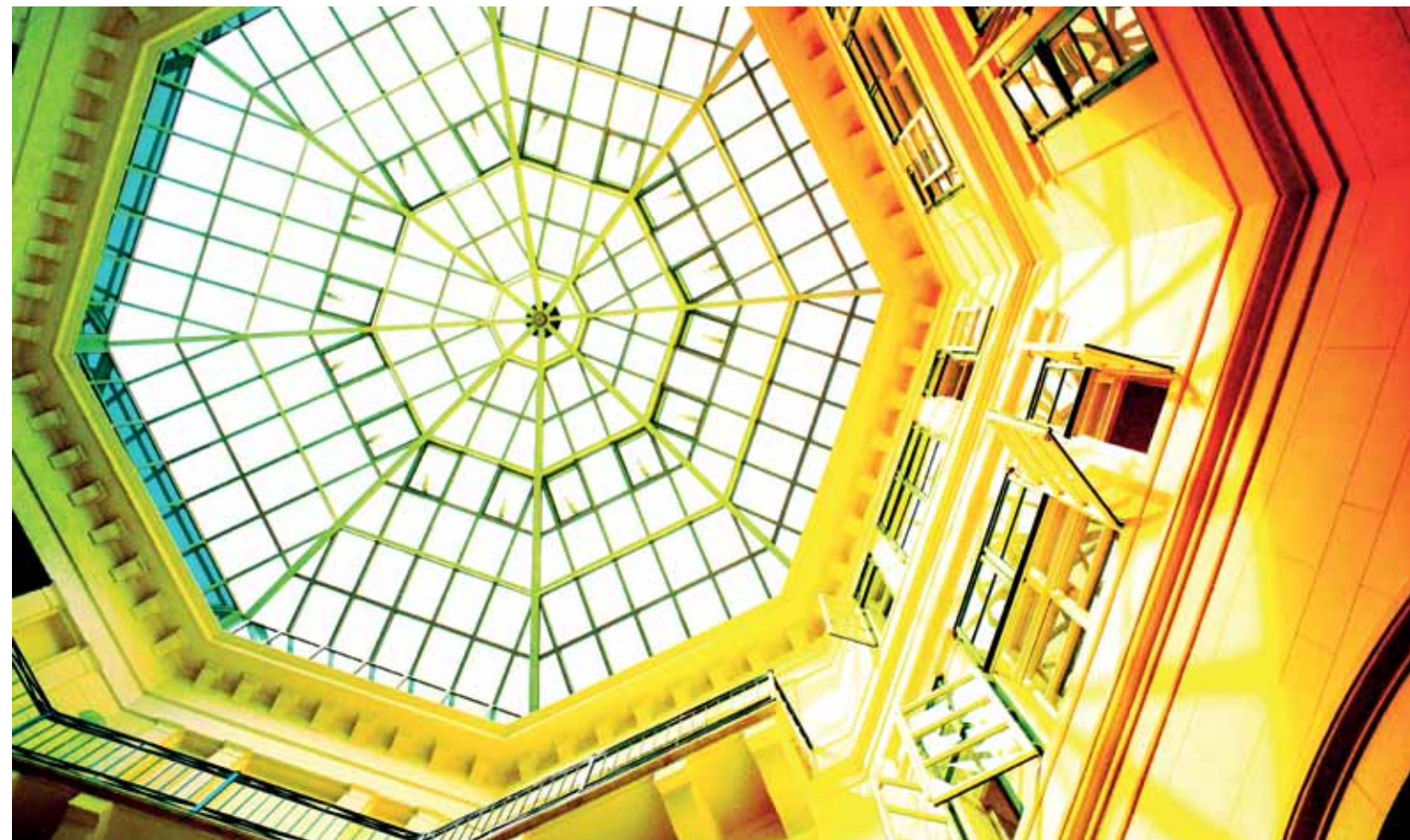
CEU has established its reputation as a research-intensive university through the outstanding work of its faculty members, 17 interdisciplinary research centers, and some dozen less structured faculty/student research groups.

From 2010 to 2012, external research funding grew by 82.8

percent, from €3.26 million to €5.96 million. Funding sources include the European Union's Framework Programs, the European Research Council, the United Nations, government agencies, private foundations, international NGOs, and other private and public sources. The European Commission, alone, is funding 42 ongoing research projects that CEU conducts in collaboration with

several dozen universities. For example within the "Quality in Gender and Equality Practices" comparative research project, CEU coordinates a research team with members from 10 European countries.

A recent example of external funding involves CEU's Center for Ethics and Law in Biomedicine, which began work in spring 2013 on a three-year



NEW KNOWLEDGE

CEU scholars shed new light on subjects both contemporary and historical. For example: Associate Professor Martin Kahanec disproved the myth that unemployment benefits in richer EU countries draw immigrants from poorer EU countries. Professor Maria M. Kovacs traced the legal roots of Hungarian anti-Semitism to higher-education quotas imposed in 1920, demonstrating that they predated Nazi influence. Cognitive scientist and Associate Professor Natalie Sebanz found that people's racial biases changed after participating in testing that made them feel their own hands were colored differently. And research fellow Amy Brouillette developed a graphic representation of Internet governance in Iran to understand how Iran's hardliners are trying to centralize state censorship.

€3.3 million project, "Neuro-Enhancement: Responsible Research and Innovation," in partnership with 17 other research centers across Europe. CEU's Department of Economics has received three highly prestigious European Research Council (ERC) grants in the past two years, enabling it to create a world-class research cluster in the field that centers on interconnected research into knowledge flows, behavioral theory, and social networks. CEU's Center for Policy Studies is collaborating with seven universities in the "Reducing Early School Leaving in the EU" research project, which aims to provide insights into students' decisions. And researchers at CEU's Center for Network Science tackle issues as diverse as creativity in teams, the role of technology in civic activism, and organizational design.

"I am devoted to guaranteeing the right to health for Latin American children. Our organization is making significant strides in improving the odds for Mexican children, in particular. We partnered recently with DHL in 29 of Mexico's 32 states to speed up vital post-natal testing that can identify treatable disabilities, reducing the wait for results from 90 days to nine. Also, we worked with Mexico's largest flour producer to add folic acid—a vitamin known to prevent birth defects—to its product, making the Mexican staple of tortillas more nutritious."

"From Togo, I travel to dozens of other lesser developed West African countries to help them cultivate climate change mitigation projects, most notably ones that focus on clean energy and energy efficiency. There are over 6,700 clean development projects from over 80 countries registered with the UN's Clean Development Mechanisms. These endeavors have resulted in over 1 billion certified emission reduction credits—more commonly known as carbon credits—that can be traded and sold and used by industrialized countries to meet part of their emission-reduction targets under the Kyoto Protocol."

ENGAGEMENT

CEU is committed to making tangible contributions to society. And one important way it contributes is via faculty work for organizations requiring expert assistance.

These are a few recent examples of sponsoring organizations and tasks: For the *European Commission*: Assessed the

implementation and enforcement of environmental law in six accession countries. For the *Organisation for Economic Co-Operation and Development*: Investigated online privacy and protection of children. For the *UN Environmental Programme*: Developed a program for promoting the Bali Guidelines on Rio Principle 10, focused on improving nations' legal structures on environ-

mental governance. And for the *Office of the UN High Commissioner for Refugees*: Provided a day of training on high-level diplomacy and negotiation to 15 senior officials.

Apart from individual projects, CEU is involved in hundreds of partnerships within the region and worldwide. The only one of its kind in the world, CEU's Roma Access Programs pre-

pare outstanding Roma students to pursue graduate-level education, conduct advocacy work, and serve as role models and leaders for the Roma community. CEU and Turkey's Sabanci University cooperate to provide financial support to projects in foreign policy, globalization, human rights, international development, conflict analysis and resolution, and democratization. CEU Business School cooperates with Hungary's National Innovation Office, the American Chamber of Commerce in Hungary, the U.S. Embassy, and the Hungarian Venture Capital Association, among others, to promote innovation and entrepreneurship. CEU's School of Public Policy hosts forums for policy professionals in partnership with bodies such as Revenue Watch International and the Migration Policy Institute.



ISSUES-FOCUSED EVENTS

CEU hosts more than 500 events a year. Internationally distinguished speakers come regularly to discuss solutions to challenges as diverse as stabilizing the euro zone, ending impunity for perpetrators of war crimes, parsing moral questions of life extension, and convincing world leaders to pursue the most far-reaching climate change policies.

Recent conferences have explored subjects including *The Individual vs. the State*, *Challenges of Urbanization*, and *The Radical Right in East Central Europe*. While prominent lectures have addressed wide-ranging topics including *The Alchemy of Austerity*, *The Tragedy of Leon Trotsky*, *Forgotten Refugees*, *Iran at a Crossroads in History*, *Living in Surveillance Societies*, and *Militarizing the Arab Spring*.
